RE: **Invitation to the Upcoming Fraser River Salmon Roadmap Workshop**
June 22nd and 23rd 2011 – Thunderbird Hall, Campbell River First Nation

This is an invitation to participate in the upcoming Fraser River Salmon Roadmap (“Roadmap”) workshop on June 22nd & 23rd in Campbell River, BC. This session follows a successful series of workshops in 2010-11, including the most recent session in Prince George in March 2011.

Both First Nations and Fisheries and Oceans Canada (DFO) have identified moving toward fisheries co-management (or joint management) as a key priority in reconciling the roles of DFO and Fraser First Nations in addressing Section 35-1 rights and current case law in fisheries management. In that context, the Roadmap initiative is aimed at building an innovative co-management structure, process, and agreement between DFO and First Nations from the Fraser River Watershed, Vancouver Island, and Marine Approach areas, related to Fraser salmon. It is not intended to define or limit aboriginal rights or alter the existing aboriginal or federal authoritative structures.

Building on previous discussions through the Roadmap, Forum on Conservation and Harvest Planning, and other forums, there is a unique opportunity between now and March 2012 (and beyond) for First Nations and DFO to work together in building a more collaborative management approach for Fraser salmon that better meets the needs and objectives of both First Nations and DFO.

The Roadmap is a participant-driven process that requires active participation, leadership, and direction from First Nations in order to be successful. As such, First Nations and DFO, through the Fraser Salmon Roadmap Planning Group, strongly encourage First Nations leaders and fisheries advisors to engage in this collaborative process (either directly or through a delegated representative) to contribute to building an innovative partnership between DFO and First Nations.

The Campbell River session will be an opportunity for First Nations and DFO to further establish the foundation for what we hope will be an innovative long-term structure and agreement around the co-management of Fraser salmon. More specifically, participants in Campbell River workshop and subsequent sessions later this year will be asked to help define the scope, potential elements, and outline of a co-management agreement, as well as the principles and next steps in order to build the content of an agreement.

The Roadmap initiative is coordinated by the Fraser Salmon Roadmap Planning Group (FSRPG) which consists of appointed members and alternates from the Fraser River Aboriginal Fisheries Secretariat (FRAFS), the Island and Marine Aquatic Working Group (IMAWG), the First Nations Fisheries Council (FNFC), and DFO.
