## Your Guide to the Fraser River Aboriginal Fisheries Secretariat: A Program Outline

The core program of the Secretariat (FRAFS) is devoted to providing communications and technical support to Fraser First Nations in relation to the management of Fraser River salmon and the fisheries that are implemented on them. The long term goal of the Secretariat is to assist First Nations and DFO to reach a more collaborative relationship in the management of the stocks and the fisheries on those stocks.

In the last few years a number of initiatives have been added to the basic annual FRAFS program. As with any organization that experiences a rapid expansion of its interests and activities, there are growing pains. These have been exacerbated in the last couple of years by having these “add-ons” put into place when the fiscal year is half over. It is no wonder that confusion has been created.

In recent months we at FRAFS have tried to simplify and clarify the various projects that we are responsible for delivering. Following is a brief description of each of the main components of the current year program:

**1. Executive Committee (EC):** Comprised of six First Nation and two DFO members, the EC is responsible for oversight and successful program completion within budget. Provides direction to the Operations Manager. Current members: Terri Bonnet and Adrian Wall (DFO); Ernie Crey, Mike Jimmie, Fred Fortier, Murray Ross, Gord Sterritt, and Thomas Alexis (FN). (Ken Malloway is the EC Chairperson.)

**2. Operations Manager (OM)** (Neil Todd): responsible for providing support to the EC as needed, project budget tracking and fiscal control, and coordination of information and technical services. Supervises the Communications Coordinator.

**3. Communications Coordinator** (Aimee Arsenault): provides communication services among First Nations and between First Nations and DFO; meeting records; maintenance of website; meeting support (venue arrangements).

**4. Biologists** (Mike Staley, Penny White, and Pete Nicklin): participate in technical processes and committees/work groups with First Nations and DFO; interpretation and analysis of DFO management policy and decisions for use by First Nations in consultation processes.

**5. Joint Technical Working Group (JTWG):** DFO and FRAFS/First Nations’ technical staff; detailed examination of information and data used as a basis for management decisions and actions; provision of the results to First Nations and DFO for use in consultation processes.

**6. Fraser Watershed Joint Technical Forum (FWJTF):** a watershed (and marine approach) wide gathering of technical and political leadership, and DFO, for presentation and discussion of technical topics to better understand technical issues in relation to management of Fraser River salmon.

**7. Forum on Conservation and Harvest Planning (“Forum”):** a watershed (and marine approach) wide gathering of technical and political leadership; to discuss specific fishery management issues for the current fishing year and attempt to arrive at common understanding among First Nations, and between DFO and First Nations, on anticipated key conservation and harvest management issues.

**8. Tier 1 Structure and Process Development Support:** financial support to the Intertribal Treaty Organization to assist that organization with building a watershed wide First Nations (“Tier 1”) organization that can support and put forward common First Nation policy and rights issues in relation to management of Fraser River salmon.

**9. Visions Workshop:** an annual watershed wide gathering where up to date information and progress on technical and political issues and events is shared.

**10. Cohen Commission technical/administrative assistance:** a budget allocation to assist with communications and assistance to the legal team for the First Nations’ Coalition group in its involvement with the Cohen Commission hearings.

**11. PST Chapter 4 Consultations:** follow-up informational meetings as part of a consultation process initiated 1.5 years ago regarding the re-negotiation of Chapter 4 of Annex IV of the Pacific Salmon Treaty, i.e. the Fraser River Panel process.

**12. Vancouver Island and Marine Aquatic Working Group (IMAWG):** a budget allocation to assist their participation and attendance in FRAFS’ Fraser Watershed activities.

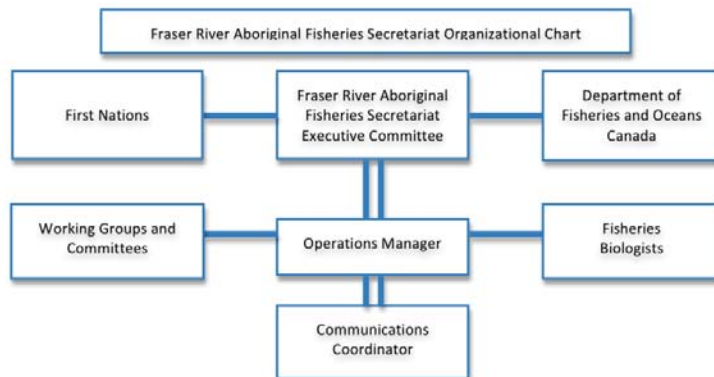
**13. Development of an Agreement between DFO and First Nations for the management of Fraser salmon** (commonly called the “Roadmap process” in the past; will now be referred to as the “**Fraser Salmon Roadmap**”): an ambitious and proactive initiative to try to assist Fraser First Nations and DFO to conduct discussions toward an arrangement that provides for meaningful participation by First Nations in the fishery management decision-making processes.

**14. Strategic Planning Group (SPG):** currently under formation, the SPG will (with the assistance of a facilitation professional) assist and guide both parties in the development of a management agreement between DFO and First Nations (project #13). This group will now be referred to as the “Fraser Salmon Roadmap Working Group” to more clearly align it with project #13 above.

**15. Forum Planning Committee (FPC):** formerly referred to as “the FRAWG”, this is a bi-lateral committee, with majority being First Nations participants, tasked with preparation of agendas for the Forum (project #7).

**16. Catch Monitoring Workshop:** a topic-specific workshop designed to provide a better understanding of the range of types of monitoring for all fisheries that target Fraser River salmon including their locations, relative strengths and weaknesses, and identification of fishery harvest monitoring gaps. This workshop was held in Richmond in November.

**17. Mid-Fraser capacity development for a co-management/collaborative structure:** a budget allocation to support exploration of the potential for First Nations in the mid-Fraser area to form an AAROM-funded collaborative working group/structure/process.

### Forum on Conservation and Harvest Planning

A reminder that a Forum on Conservation and Harvest Planning will be held at the Executive Airport Plaza Hotel (Westminster Room) on January 25th (Tier 1) and 26th (Tier 2).

The workshop will discuss specific fisheries management issues for the current fishing year (2011) and attempt to build common understanding between First Nations and Fisheries and Oceans Canada on key conservation and harvest management issues.

## Aquaculture Community Dialogue Sessions Hosted by the First Nations Fisheries Council

The First Nations Fisheries Council and the Aquaculture Working Group will be hosting a series of community dialogue sessions in February 2011. The sessions will kick off with a joint DFO and Aquaculture Working Group meeting to discuss the development of Integrated Management of Aquaculture Plans and the management framework for aquaculture in British Columbia. This joint session will be followed by a series of First Nations regional community sessions.

These meetings will be an opportunity for First Nations to learn more about the proposed aquaculture management framework for B.C., ask important questions, and provide feedback to the development of the management framework for B.C. aquaculture. These sessions will provide a unique opportunity to influence emerging management systems and policies to better reflect the views, priorities and perspectives of B.C. First Nations.

All meetings are open to B.C. First Nations or persons working with B.C. First Nations who have an interest in how aquaculture (shellfish, finfish, and enhancement activities) will be managed in B.C. under the new DFO lead regime.
